The 2018 Thirteenth Northeast Asia Economic Forum Young Leaders Program

Overview

The 13th Young Leaders Program organized by Northeast Asia Economic Forum (NEAEF) and University of Hawai'i, College of Social Sciences was held during July 24 – August 10, 2018. The Program was hosted by Tohoku University with the support from the Freeman Foundation (which started 13 years ago at its inception), and contributions from China Asia Pacific Institute, Korea Asia Pacific Institute, and other cooperating institutions in Northeast Asia.

Because of the importance of the internationally recognized Sendai Framework for disaster due to the 2011 Fukushima tsunami, the 2018 Young Leaders Program was preceded this year by joining the activities of the Association of Pacific Rim Universities - Multi-Hazards (APRU-MH) Summer School, for two days.

Program Goals and Outline

The main goals of YLP are to:

- 1. Enhance knowledge of the social, economic and political institutions of the individual countries in Northeast Asia and North America.
- 2. Encourage young leaders to consider a wide range of perspectives on regional and multilateral economic cooperation.
 - 3. Prepare YLP fellows to work collaboratively and internationally.
 - 4. Provide them with practical education in policymaking through opportunities of direct dialogue with policymakers and other experts.
 - 5. Foster a sense of community among young leaders.
- 6. Promote a better understanding among individuals, countries and cultures in Northeast Asia and the United States.

Number of Countries Represented and Qualifications of YLP participants

There were 31 participants from countries of Northeast Asia: China (8), Japan (2), Korea (4), Mongolia (3), Russia (5), USA (8), and a Kenyan PhD student from Tohoku University. Forty-two percent of them are female. The detailed qualifications are tabulated in Appendix 1.

The participants were young professionals, junior faculty members, postdoctoral researchers, and graduate students pursuing advanced degrees in economics, business, law, sociology, political science, environmental sciences, or related disciplines. In the recent past, most of the participants were either PhD students matriculating or who had completed their graduate degrees at major prominent universities. For example, a couple of Rhodes Scholars from Oxford University in the UK were participants.

- Participants are divided into six groups to introduce member countries Northeast Asia Economic Forum: China, Japan, Korea, Mongolia, Russia and the USA with an understanding that a participant cannot be in a group introducing his own country. This way participants are encouraged to learn about another country in the region in an objective way, thereby reducing the nationalistic tendencies and lowering state sovereignty walls and thus called "area presentation".

Program Evaluation

The anonymous 3-page, 11-item evaluation was administered as the final activity of the YLP. Their responses indicated a very high level of overall satisfaction and appreciation with about 92% saying that the program either met or exceeded their expectations. Almost all participants said that the administration of the program was sufficiently responsive to their interests and needs while only one participant said otherwise.

When asked which part of the program is the strong in which they gained the most, they mentioned most of the YLP components as follows:

- Lectures by invited experts/speakers
- IRIDeS Summer School and Field Trip
- Individual presentations
- · Policymakers' meeting with YLP participants
- NEAEF Conference
- Group interactions/discussions
- Mutual introduction of participants

A sample of their unedited comments is provided below:

- "The team is very strong and considerate, under the leadership of Dr. Cho. The preparation work is well designed, organized, and carried out. The system and mechanism of managing the whole projects are effective. My interest and need are well met."
- "It was excellent! I have been to few conferences abroad and I can say from my previous experience that the YLP was the best in terms of logistics. Thank you."
- "I'm glad there are so many experts from different fields. I'm grateful and it's my honor to join in this program. And at the end of YLP, we, young people, can have interview with policymakers. This is the most impressive part of the program."
- "The strongest part of the program for me was the group presentations. I developed further my team working skills and group management abilities. I also engaged myself in topics completely new to me."
- "The coordination by the program administrators was superb. The program was also accommodating especially with time for comments and discussions. Everyone had time to communicate their interests."

NEAEF Conference Evaluation

Most of the YLP Fellows indicated that the NEAEF conference met their expectations. The conference presenters provided the YLP Fellows a broad perspective on regional cooperation.

In conclusion, the 2018, 13th Young Leaders Program has received highly positive response across all aspects covered by the evaluation and resulted in an outstanding success.
